ORDINANCE NO. 1008, S-2025

AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 697, S-2018 PROVIDING FOR ADDITIONAL CEMETERY SERVICES (BOOKSHELF COLUMBARIUM) IN THE GARDEN OF LIFE PARK CITY OF MANDALUYONG AND PRESCRIBING FEES THEREFORE

WHEREAS, it is the policy of the City Government of Mandaluyong to provide decent and accessible burial services to the departed *bonafide* residents of the City of Mandaluyong pursuant to its mandate in providing efficient and effective basic services and facilities such as public cemetery, among others:

WHEREAS, in furtherance of its mandate, the City enacted Ordinance No. 697, S-2018, prescribing fees, charges, policies, guidelines, implementing rules and regulations for the operation, maintenance and services offered in the Garden of Life Park Mandaluyong City inclusive of private or apartment niches, memorial chapel, mausoleums, crematorium and columbarium;

WHEREAS, to reinforce the provision of basic services and facilities to the departed constituents of the City and in response to the increasing need of affordable alternative for corpse disposal, the City Government of Mandaluyong through the City-owned Garden of Life Park establishes additional One Thousand Five Hundred Twenty (1,520) units of bookshelf columbarium annexed in the public cemetery;

WHEREAS, in order to effectively manage the operation, maintenance, and preservation of the public cemetery annexed bookshelf columbarium, there is a need for the Sangguniang Panlungsod to prescribe rental fees for its use to pave the way for shouldering the utility expenses for its sustentation.

NOW, THEREFORE, be it ENACTED, as it is hereby ENACTED, by the Sangguniang Panlungsod of Mandaluyong City, Metro Manila, by virtue of the powers vested in it by law, in session assembled:

SECTION 1. Section 7 (D) of Ordinance No. 697, S-2018 is hereby amended inserting a new sub-section 7 (D-1) which will read as follows:

SECTION 7. GLP FEES AND CHARGES. The new rates for the cemetery services are imposed as follows:

- SECTION 2. IMPOSITION OF FEE. The imposition of the above-prescribed fees for the public cemetery annexed bookshelf columbarium shall be fully implemented by the Mandaluyong City Garden of Life Park (GLP) Committee in March of 2025.
- SECTION 3. SEPARABILITY CLAUSE. Any provision or portion of this Ordinance found to be violative of the Constitution or otherwise declared to be invalid shall not impair other provisions or parts thereof and shall continue to be in force and effect.
- SECTION 4. REPEALING CLAUSE Ordinances, rules and regulations, or any parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.
- SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval and publication in a newspaper of general circulation.
