ORDINANCE NO. 1028, S-2025

AN ORDINANCE INCREASING THE ALLOWANCES GRANTED TO STATIONED METROPOLITAN TRIAL COURT (MeTC) AND REGIONAL TRIAL COURT JUDGES (RTCs) IN THE CITY OF MANDALUYONG, THEREBY AMENDING ORDINANCE NO. 742, S-2019

WHEREAS, the Local Government Code of 1991, as an inherent right of local government units, sanctions the Sangguniang Panlungsod to approve ordinances and pass resolutions for an efficient and effective city government;

WHEREAS, the City Government recognizes the significant role of the judges in the Metropolitan Trial Courts (MeTCs) and Regional Trial Courts (RTCs) in the City's peace and order;

WHEREAS, Section 458 (1) (xi) of the same Code allows the granting of allowances to judges subject to the capability of the City to provide the same, stating that:

“(xi) When the finances of the city government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned in the city;”

WHEREAS, the City has initially exercised its local autonomy and allocated allowances to MeTC and RTC judges, as evidenced by City Ordinances No. 529, S-2014 and 633, S-2016, setting the allowance at Twenty Thousand Pesos (Php20,000.00);

WHEREAS, in 2019, the allowances granted to MeTC and RTC judges was further increased by virtue of City Ordinance No. 742, S-2019;

WHEREAS, an assessment of the allowances currently given to MeTC and RTC judges reveals that there is a need to increase the same in order to recognize the effective and efficient ways our local courts have disposed of disputes and dispersed justice.

NOW, THEREFORE, BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong City, by virtue of the powers vested in it by law, in session assembled:

SECTION 1. The City of Mandaluyong hereby grants stationed MeTC and RTC judges in the City of Mandaluyong the following allowances, subject to all legal and auditing rules and to the limitations set forth by law:

A. REGIONAL TRIAL COURTS (RTCs)

1 Executive Judge	Php43,000.00	Php43,000.00
12 Presiding Judges	Php40,000.00 each	Php480,000.00

B. METROPOLITAN TRIAL COURTS (MeTCs)

1 Executive Judge	Php43,000.00	Php43,000.00
7 Presiding Judges	Php40,000.00 each	Php280,000.00

SECTION 2. The allowance shall cover all appointed MeTC and RTC stationed in the City of Mandaluyong, including those which may be later appointed after the enactment of this Ordinance, provided that the City has available funds for the purpose.

SECTION 3. The allowance shall be given to the judges on a monthly basis and may be adjusted subject to the discretion of the City in the exercise of its local autonomy.

SECTION 4. Upon the death, retirement, termination, or transfer of any judge covered by this Ordinance to another designation, office, or local government unit, the allowance shall be automatically discontinued.

SECTION 5. The allowance shall be given per judge, regardless of the number of courts over which the judge presides.

SECTION 6. The sum of Eight Hundred Forty Six Thousand Pesos (Php846,000.00) is hereby allotted and allocated monthly, subject to the relevant accounting and auditing laws, rules, and regulations.


SECTION 7. If, for any reason, any article or provision of this Ordinance or any portion thereof or the application of such article, provision or portion thereof to any person, group or circumstance is declared invalid or unconstitutional, the remainder of this Ordinance shall not be affected by such decision.

SECTION 8. All ordinances, resolutions, executive issuance, or rules and regulations, or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby repealed, amended, or modified accordingly.

SECTION 9. This Ordinance shall take effect immediately after its approval.






