ORDINANCE NO. 315, S-2005

**AN ORDINANCE ADOPTING THE OFFICIAL POLITICAL
 MAP OF THE CITY OF MANDALUYONG**

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Mandaluyong, in session assembled:

SECTION 1. This Ordinance shall be known as the "Official Political Map of the City of Mandaluyong, Metro Manila";

SECTION 2. POLITICAL DISTRICTS – In accordance with Republic Act 7675 known as the City Charter of Mandaluyong, the two (2) political districts shall be maintained and known as the First (1st) and Second (2nd) Districts. Copy of the map duly certified by the City Planning Development Office (CPDO) is hereby attached and made as integral part of this Ordinance. (See Appendix 1)

SECTION 3. a.) COMPOSITION OF THE FIRST DISTRICT. The following barangays shall compose the first political district of Mandaluyong:
