### ORDINANCE NO. 377, S-2007

## AN ORDINANCE PRESCRIBING A DRESS CODE IN PUBLIC PLACES IN THE CITY OF MANDALUYONG

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of Mandaluyong, in session duly assembled:

- SECTION 1. TITLE. This Ordinance shall be known as the Mandaluyong City Dress Code.
- SECTION 2. The City Government of Mandaluyong hereby prescribes that all persons must be properly and decently attired while moving about in public places within the City of Mandaluyong.
- SECTION 3. No person shall move about (i.e. walk, jog, run or the like) in public places and outside his private residence half-naked or wearing clothing covering only the lower most portion of the body without top apparel.

### SECTION 4.

- A. Market vendors/sellers, whether in government—owned or privately owned markets must be attired as follows:
  - a. T-shirt, Blouse or any top apparel with sleeves
  - b. Pants or Skirts
  - c. Shoes, sandals or step-in
  - d. Apron, for vendors in the wet section and in the kitchen section of carinderia.
- B. Food servers should wear prescribed uniform or any decent clothing with sleeves
- SECTION 5. PROHIBITED MANNER OF DRESSING. The following manner of dressing by vendors/sellers in the market sites are prohibited:
  - a. going topless or half-naked
  - b. wearing short shorts
  - c. wearing sando or any sleeveless shirt
  - d. wearing slippers
  - e. wearing dirty or tattered clothes

### SECTION 6. DEFINITION OF TERMS.

- a. Topless-half-naked or wearing clothing covering only the lower most portion of the body with the absence of a top apparel.
- b. Public Places
  - Open public places include but not limited to the following: roads, streets, sidewalks, parks, bridges, alleys, overpasses and uncovered basketball courts.

- 2. Covered public places include but not limited to the following: schools, colleges, universities, museums, clinics, hospitals, health centers, dispensaries, laboratories, government or private offices, auditoriums/stadium/gymnasium/session halls, churches, convention centers, theaters/movie house studio, bars, restaurants/cocktail lounges/canteen/kiosk, and other enclosed public eating places, dance halls/disco houses, day and night clubs, beer/pub houses, hotels, department stores, markets/groceries, factories, plants and other covered places where people stay or gather for political, social, educational, religious, sports or entertainment purposes.
- c. Short shorts trouser covering less than ¼ of the lower torso and legs.
- d. Slippers includes bedroom slippers, rubber sandals or any other footwear/ footgear commonly classified as "tsinelas".
- SECTION 7. PENALTY. Any person apprehended for violating this Ordinance, shall be penalized with a fine of Five Hundred Pesos (P500.00) at each instance. In case of insolvency, the offender shall render one-day community service under the supervision of the Waste Management Office or the City Health Office.
