AN ORDINANCE AMENDING ORDINANCE NO. 183, S-1998 FIXING THE FEES FOR THE ISSUANCE OF POLICE CLEARANCE

BE IT ORDAINED by the Sangguniang Panlungsod, in session assembled:

SECTION 1. The following fees shall be assessed and collected by the City Treasurer of Mandaluyong for the issuance of the following clearances by the City Police Office, City of Mandaluyong, to wit:

a.	For identification and local employment	P 125.00
b.	For business and other commercial purposes	200.00
C.	For travel abroad, visa requirement and passport	300.00
d.	For firearms license	300.00
е.	For naturalization	500.00
f.	For seaman's book	200.00
g.	For adoption purposes	200.00

SECTION 2. No clearance shall be issued by the City Chief of Police or his authorized representative unless the corresponding fees are paid.

SECTION 3. Ordinance No. 183, S-1998 is hereby repealed.

SECTION 4. This Ordinance shall take effect upon approval.
