ORDINANCE NO. 427, S-2009

AN ORDINANCE RENAMING KAPOK STREET IN BARANGAY
BARANGKA ITAAS, CITY OF MANDALUYONG,
TO JOSE C. SALINGA STREET, AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Panlungsod, City of Mandaluyong, in session assembled, that:

- SECTION 1. The whole stretch of Kapok Street, a barangay road in Barangka Itaas, City of Mandaluyong, shall henceforth, be renamed as JOSE C. SALINGA ST. to honor and perpetuate the memory of the first *tiniente del barrio* and elected Barangay Captain of Barangka Itaas in 1986, who had resided on said Kapok Street, since his birth and until his death in March 1996.
- SECTION 2. The herein—above cited change of street name is pursuant to the attestations of Barangka Itaas Barangay a Council in its Resolution No. 02, Series of 2007 that no documentations show that the name Kapok St. had been derived from historical and/or significant origin, and that “... *there are no testimonies of early and present settlers that confirm it has importance in the form of any event or circumstances that took place in our neighborhood during past and present times*”.
- SECTION 3. The new street name JOSE C. SALINGA ST. shall henceforth be used on the postal address and identification system of the residents thereon.
- SECTION 4. The following offices or agencies shall each be furnished a copy of this Ordinance:
- The National Historical Institute for its information and record purposes;
 - The Mandaluyong City Planning and Development Office for its information and corresponding change and annotation in the Official Political Map of the City of Mandaluyong;
 - The Mandaluyong City Engineering Department for its information and corresponding change of the street sign to JOSE C. SALINGA ST.;
 - Mandaluyong Central Post Office;
 - Other concerned local government offices or agencies.
- SECTION 5. This Ordinance shall take effect immediately upon its approval.
