ORDINANCE NO. 500, S-2012

**ORDINANCE REGULATING THE ESTABLISHMENT AND OPERATION
OF CUSTODIAL PSYCHIATRIC CARE CLINIC AND DRUG ABUSE
TREATMENT AND REHABILITATION CENTER**

BE IT ENACTED by the Sangguniang Panlungsod in session assembled:

SECTION 1. SCOPE AND COVERAGE. The provisions of this Ordinance shall apply to the establishment and operation of Custodial Psychiatric Care Clinics, Drug Abuse Treatment and Addiction Recovery Rehabilitation Centers in the City of Mandaluyong.

SECTION 2. In addition to the requirements of the Bureau of Health Facilities and Services, Department of Health, no Mayor's Permit to establish and operate a Custodial Psychiatric Care Clinic, Drug Abuse Treatment and Addiction Recovery Rehabilitation Center in the City of Mandaluyong shall be issued unless the following requirements are complied with, to wit:

A. DOCUMENTARY REQUIREMENTS

1. Department of Health Clearance;
2. Barangay Locational Clearance;
3. Neighbors consent (within 100 meters radius) for clinics/centers located in residential areas with Barangay Certification stating that the neighbors consent had been verified; and
4. Exterior and interior photographs of establishment

B. PHYSICAL REQUIREMENTS

1. Administrative Office
 - near the entrance
2. Reception and Waiting Area
 - located near the entrance and immediately accessible to patient
3. Counseling and Testing Room
 - near reception area
4. Emergency Clinic
5. Living Quarters
 - (at least 3 sq. m. per bed)
 - separate for male and female

6. Toilet and Bath

- (1.10 ratio)
- Separate for male and female
- minimum of one toilet per floor accessible to handicapped inmate

7. Staff Toilet

8. Indoor Activity Area

9. Outdoor Activity Area

10. Kitchen with Grease Trap (Ordinance no. 436, S-2009)

11. All window openings provided with sun breaker/fixed (to obstruct view from exterior)

12. Sound Proof Building

13. Security Detail/Post, Alarm System

C. OTHER REQUIREMENTS

1. Sanitary Permit (Section 54, Ordinance No. 312, S-2005)
2. PDEA Clearance (use of drugs/medication)
3. Disaster Contingency Plan
4. Other Environmental Safeguards
5. Comprehensive Public Liability Insurance

SECTION 3. No person who have raised the defense of insanity in a criminal case filed against him shall be admitted in any of the afore-enumerated establishments regulated under this Ordinance.

A violation of this provision shall result to the cancellation of the Mayor's Permit of the erring establishment.

SECTION 4. Any person found establishing and/or operating a Custodial Psychiatric Care Clinic and Drug Abuse Treatment and Rehabilitation Center without a Mayor's Permit shall be punished with a fine of not less than One Thousand Pesos (P1,000.00) but not more than Five Thousand Pesos (P5,000.00) or imprisonment of not less than two (2) months but not more than six (6) months, or both, at the court's discretion.

SECTION 5. If the offender is a juridical person, the penalty prescribed above shall be imposed upon the President and/or General Manager of the corporation or to the Managing Partner of the partnership, as the case may be.

SECTION 6. The same penalty shall be imposed upon any official or employee of the City of Mandaluyong who shall issue or cause to be issued a Mayor's Permit to any of the establishments mentioned above that has not fully complied with the requirements herein prescribed.

SECTION 7. This Ordinance shall take effect fifteen (15) days after publication in a newspaper of general circulation in the City of Mandaluyong.

ENACTED on this 9th day of July, 2012 in the City of Mandaluyong.

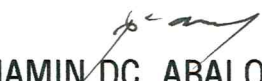
