ORDINANCE NO. 561, S-2014

ORDINANCE PRESCRIBING FEES FOR THE USE OF THE CITY GYMNASIUM AND ITS FACILITIES

BE IT ENACTED by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

SECTION 1. FEES. The following fees shall be assessed for the use of the CITY GYMNASIUM and its facilities, to wit:

Basketball Court	P 330.00/hour
Electronic scoreboard	P 365.00/game
Sound System	P 1,100.00/event
Spotlight	P 550.00 each/event
Concert and other allied events	P 2,200.00/event
Boxing, volleyball and other Sports events	P 2,200.00/event

- SECTION 2. EXEMPTION. The above fees shall not apply to government sponsored activities or events including basketball and volleyball games, tournaments or competitions as certified by the Office of the Mayor.
- SECTION 3. The Gymnasium Administrator's Office shall be responsible for the issuance of the Order of Payment. Payment shall be made at the Treasurer's Office.
- SECTION 4. PENALTY. Any person found using the gymnasium and its facilities without paying the fees prescribed in Section 1 hereof shall be punished with imprisonment of not more than thirty (30) days or a fine not exceeding Five Hundred Pesos (P500.00) or both, at the discretion of the Court.
- SECTION 6. OTHER PENALTY. The same penalty shall be imposed upon any employee of the City Government assigned at the Gymnasium who shall allow the use of the Gymnasium and its facilities without payment of the prescribed fees.
- REPEALING CLAUSE. Ordinance No. 201, S-1999 and any Ordinance not SECTION 7. consistent with the provisions of this Ordinance are hereby repealed.
- SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
