ORDINANCE NO. 911, S-2022

AN ORDINANCE GRANTING THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) AS SERVICE RECOGNITION INCENTIVE (SRI) FOR FY 2022 FOR QUALIFIED EMPLOYEES OF THE CITY GOVERNMENT OF MANDALLIYONG

WHEREAS, on December 16, 2022, President Ferdinand Marcos, Jr. issued Administrative Order No. 01 (AO 01) authorizing the grant of Service Recognition Incentive to Government Employees for FY 2022 at a uniform rate not exceeding Twenty Thousand Pesos (P20,000.00) in favor of each qualified government employee in recognition of his or her hardwork, commitment and dedication to public service;

WHEREAS, the government continues to acknowledge all public servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of services to the public, especially in the midst of the public health emergency due to the COVID-19 pandemic and recovery efforts;

WHEREAS, AO 01 likewise covers employees of the Local Government Units (LGUs), and authorizes the LGUs to grant one-time SRI to be determined by the local sanggunian depending on the financial capability of such LGU in an amount not exceeding P20,000.00, subject to Personal Services (PS) limitation under RA 7160. The SRI shall be chargeable to the FY 2022 funds of the LGU.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

- SECTION 1. SERVICE RECOGNITION INCENTIVE (SRI) FOR QUALIFIED EMPLOYEES OF THE CITY GOVERNMENT OF MANDALUYONG In the exercise of prudence and judicious use of government funds, a uniform Service Recognition Incentive in the amount of Ten Thousand Pesos (P10,000.00) shall be granted to each qualified employee of the City Government of Mandaluyong, subject to the conditions set forth in Section 2 hereof.
- SECTION 2. CONDITIONS ON THE GRANT OF THE SRI The SRI shall be granted subject to the following conditions:
 - The civilian personnel are occupying a regular, contractual, or casual positions;
 - b. The personnel are still in the government service as of November 30, 2022;
 - c. The personnel have rendered at least a total or an aggregate of four (4) months of satisfactory service as of November 30, 2022, inclusive of services rendered under any of the alternative work arrangements prescribed by the Civil Service Commission;

d. Those who have rendered less than a total or aggregate of four (4) months of satisfactory service as of November 30, 2022 shall be entitled to a pro-rated share of the SRI in the following schedule:

Length of Service	Percentage of SRI
3 months but less than 4 months	40%
2 months but less than 3 months	30%
1 month but less than 2 months	20%
less than 1 month	10%

and;

- e. The personnel have not received any additional year-end benefit in FY 2022 over and above the benefit authorized under RA 6686, as amended by RA 8441.
- SECTION 3. EXCLUSIONS FROM THE GRANT OF THE SRI Those engaged with the City having no employer-employee relationship and whose compensation are funded from non-Personnel Services (PS) appropriations/budgets are excluded from the grant of SRI:
 - Consultants and experts engaged for a limited period to perform specific activities or services with expected outputs;
 - b. Laborers engaged through job contracts (pakyaw) and those paid on a piecework basis;
 - c. Student workers and apprentices; and
 - d. Individuals and groups of people whose services are engaged through job orders, contracts of service, or others similarly situated.
- SECTION 4. SOURCE OF FUND The SRI shall be chargeable against the available funds of the City Government of Mandaluyong for FY 2022, subject to the PS limitation in LGU budgets pursuant to Sections 325(a) and 331(b) of RA 7160;
- SECTION 5. SEPARABILITY CLAUSE If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, its remaining provisions shall remain in full force as though this Ordinance did not originally include such invalid, illegal, or unenforceable provision.
- SECTION 6. EFFECTIVITY This Ordinance shall take effect immediately after approval.
