ORDINANCE NO. 972, S-2024

ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 697, S-2018, THEREBY INCREASING THE FEES IMPOSED UPON THE USE OF THE GARDEN OF LIFE CHAPEL

WHEREAS, it is the policy of the City Government of Mandaluyong, as part of its mandate, to provide accessible burial services to its departed residents of Mandaluyong City, while undertaking to continuously maintain operations of the City-established Garden of Life Park;

WHEREAS, for this purpose, Ordinance No. 697, S-2018 was enacted, prescribing the schedule of fees and charges, policies, guidelines, implementing rules and regulations for services rendered by the Garden of Life Park;

WHEREAS, under the cited Ordinance, apart from the general fees and charges for the services rendered in the Garden of Life Park, it imposes a daily fee, under Section 7 of the said Ordinance, One Thousand Two Hundred Pesos (Php1,200.00) for the use of the chapel for a maximum period of five (5) days;

WHEREAS, considering the need to update the fees imposed upon the use of chapel situated in the Garden of Life Park for its operation, maintenance, and preservation as well as the payments made to shoulder the utility expenses for the use of the same, it is incumbent upon the Sangguniang Panlungsod to introduce an amendment to the rental fees of the chapel.

NOW, THEREFORE, be it ENACTED, as it is hereby ENACTED, by the Sangguniang Panlungsod of Mandaluyong City, Metro Manila, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. Section 7 of Ordinance No. 697, S-2018 is hereby amended and read as follows:

"SECTION 7. GLP FEES AND CHARGES. The new rates for the cemetery services are imposed as follows:

SECTION 2. Let copy of this Ordinance be furnished to the Mandaluyong City Garden of Life Park (GLP) Committee and other departments, offices, and agencies concerned for their information, guidance, and reference.

SECTION 3. SEPARABILITY CLAUSE – Any provision or portion of this Ordinance found to be violative of the Constitution or invalid shall not impair the other provisions or parts thereof which shall continue to be in force and in effect.

SECTION 4. REPEALING CLAUSE – Ordinances, rules, and regulations or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE – This Ordinance shall take effect upon its approval and after publication in a newspaper of general circulation in Metro Manila.
