ORDINANCE NO. 996, S-2024

AN ORDINANCE AMENDING ORDINANCE NO. 637, S-2016 GRANTING FIVE THOUSAND PESOS (P5,000.00) MONTHLY ALLOWANCE TO THE MEMBERS OF THE SENIOR CITIZENS ADVISORY BODY

BE IT ORDAINED by the Sangguniang Panlungsod, upon motion duly seconded, in session assembled:

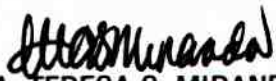
- SECTION 1. TITLE. This Ordinance shall be known as: An Ordinance Granting Five Thousand Pesos (P5,000.00) to the Members of the Senior Citizens Advisory Body.
- SECTION 2. ENTITLEMENT. The President-elect of the Senior Citizens Association of every Barangay in the 2024 Election in accordance with its Constitution and By-Laws, and who sits as members of the Advisory Body shall be entitled to the allowance provided under Section 1 hereof.

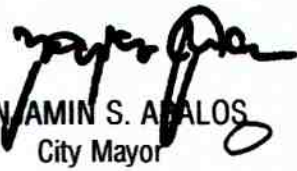
