ORDINANCE NO. 997, S-2024

AN ORDINANCE AMENDING ORDINANCE NO. 737, S-2019 GRANTING TWO THOUSAND PESOS (P2,000.00) MONTHLY ALLOWANCE TO THE VICE PRESIDENTS AND ALL THE MEMBERS OF THE BOARD OF DIRECTORS OF THE ASSOCIATION OF SENIOR CITIZENS CHAPTERS IN MANDALUYONG (ASCIM) LOCATED IN THE TWENTY SEVEN (27) BARANGAYS OF THE CITY OF MANDALUYONG

WHEREAS, it is a declared policy under the 1987 Constitution that territorial and political subdivisions of the Republic of the Philippines, such as the City of Mandaluyong, enjoy local autonomy;

WHEREAS, the Congress of the Philippines enacted Republic Act No. 7160, as amended otherwise known as the "Local Government Code of 1991" providing a system of decentralization, and allocating among the different Local Government Units their powers, responsibilities and resources, and provide for the qualifications, election, appointment and removal, term, salaries, powers and functions and duties of local officials and all other matters relating to their organization and operation;

WHEREAS, there are now twenty seven (27) barangays within the territorial domain of Mandaluyong which have established its Association of Senior Citizens (ASCIM);

WHEREAS, each chapter has its own Board of Directors whose purpose/desire is to serve their best for the betterment of their members through interaction among themselves and the dissemination of information regarding existing Ordinances; locating or identifying indigent constituents for recording purposes and gathering of data of bedridden patients who need geriatric and health facilities;

WHEREAS, the City Government recognizes the invaluable contribution of Senior Citizens' Vice Presidents and Board of Directors numbering Two Hundred Ninety Six (296) persons, more or less, comprising the different marginalized sector chapters in the twenty—seven (27) Barangays of the City of Mandaluyong, thus as such, the Sangguniang Panlungsod being aware of their needs and as a gesture of compassion, love and respect to its Senior Citizens, hereby recommends to the Local Chief Executive, Honorable City Mayor BENJAMIN S. ABALOS the approval of this Ordinance pursuant to the provisions of Section 458 of Republic Act 7160 to grant the appeal and/or request.

NOW, THEREFORE, BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong, in regular session duly assembled:

SECTION 1. There are twenty seven (27) chapters of the Association of Senior Citizens located in twenty seven (27) barangays in the City of Mandaluyong whose Board of Trustees ranges from nine (9) to thirty-three (33) members.

SECTION 2. The City Government hereby grants the amount of TWO THOUSAND PESOS (P2,000.00) a month for the duly elected/appointed Vice President and Board of Trustees of each chapter organization, subject to the availability of funds, to wit:

- SECTION 3. The grant in the amount of Six Hundred Forty Thousand Pesos (P640,000.00) per month or a total of Seven Million Six Hundred Eighty Thousand Pesos (P7,680,000.00) per annum shall be allotted for the purpose.
- SECTION 4. The member-beneficiaries concerned shall receive the subject allowances as long as they remain to be as bonafide and incumbent officers in the Barangay where they belong and shall automatically be discontinued upon resignation or death.
- SECTION 5. This Ordinance shall take effect after approval.
