## ORDINANCE NO. 999, S-2024

ORDINANCE LIFTING THE STATE OF CALAMITY WITHIN THE CITY OF MANDALUYONG AS PREVIOUSLY DECLARED UNDER ORDINANCE NO. 991, S-2024

WHEREAS, Typhoon Carina, which hit Metro Manila on 24 July 2024, had caused severe damage to infrastructure, agriculture, and private properties in the National Capital Region, including the City of Mandaluyong, resulting in widespread destruction and disruption of livelihood, as well as displacement and deaths of individuals;

WHEREAS, for this purpose and during its onset, the Metro Manila Council approved a Resolution declaring the National Capital Region under the State of Calamity in light of the impact of the massive flooding brought by Typhoon Carina;

WHEREAS, Section 16 of Republic Act No. 10121 otherwise known as "Philippine Disaster Risk Reduction and Management Act of 2010" provides that the declaration and lifting of the state of calamity may be issued by the local Sanggunian, upon the recommendation of the Local Disaster Risk Reduction and Management Council (LDRRMC), based on the results of the damage assessment and needs analysis;

WHEREAS, in line with the same, the City of Mandaluyong, likewise, approved Ordinance No. 991, S-2024 on July 29, 2024, declaring the City under a State of Calamity, thus, facilitating the orderly release of emergency funds, expedite necessary repairs and rehabilitation efforts across the City, and allow unhampered access to financial aid from the National Government, all in view of protecting and promoting the safety and security of its constituents;

WHEREAS, the disastrous effects and aftermath of Typhoon Carina was further seen after the same left the Philippine Area of Responsibility, with the City Government of Mandaluyong expeditiously acting upon and reacting on the adverse and irreversible effects of the said Typhoon;

WHEREAS, at the present time and upon the assessment and recommendation of the City Disaster Risk Reduction and Management Council (CDRRMC), there exists justifiable grounds to lift the City's previous declaration, through this Sangguniang Panlungsod, of the state of calamity;

WHEREAS, in view of the same and the reversion of the City of Mandaluyong of its livable conditions prior to the entry of Typhoon Carina, the Sangguniang Panlungsod deems it necessary to recognize the present status of the City of Mandaluyong and lift its previous declaration under Ordinance No. 991, S-2024;

NOW, THEREFORE, be it ORDAINED as it is hereby ORDAINED, by virtue of the powers vested in the Sangguniang Panlungsod of Mandaluyong, in a session duly called and assembled, hereby lifts the State of Calamity status within the City of Mandaluyong as previously declared under Ordinance No. 991, S-2024.

ORDAINED FURTHER, that all prior ordinances, resolutions, and other similar issuances that are effective only during the State of Calamity shall be deemed withdrawn, revoked or canceled and shall no longer be in effect.

ORDAINED FURTHERMORE, that the CDRRMD is directed to furnish the Sangguniang Panlungsod a copy of their consolidated report and assessment on the activities undertaken after the onslaught of "Typhoon Carina" and until the effectivity of this issuance, for its reference.

ORDAINED FINALLY, that copies of this Ordinance be furnished to the Office of the City Mayor, the City Disaster Risk Reduction and Management Department, the City Disaster Risk Reduction and Management Council, the City Health Department, the City Social Welfare and Development Department, and other pertinent departments and offices of the City Government of Mandaluyong.

ADOPTED on this 14th day of October 2024, in the City of Mandaluyong.
