RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT CONTRACT WITH KYRO BUILDERS, INC. FOR THE STREET IMPROVEMENT (ASPHALT OVERLAY) LOCATED AT J. CARDINAL SIN STREET (SHAW BLVD. TO NUEVE DE PEBRERO STREET), BARANGAY PLEASANT HILLS, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the street improvement (asphalt overlay) located at J. Cardinal Sin Street (Shaw Blvd. to Nueve de Pebrero Street), Barangay Pleasant Hills, City of Mandaluyong;

WHEREAS, on July 4, 2022 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein three (3) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the three (3) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Kyro Builders, Inc., with business address at #14 Ongjiangco Street, Sta. Veronica, Guimba, Nueva Ecija has been established to have the Lowest Calculated Responsive Bid in the amount of FOUR MILLION FOUR HUNDRED NINETY NINE THOUSAND SIX HUNDRED FIFTY PESOS (₱4,499,650.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Kyro Builders, Inc. is the lowest and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS, to sign the Project Contract with Kyro Builders, Inc. for the street improvement (asphalt overlay) located at J. Cardinal Sin Street (Shaw Blvd. to Nueve de Pebrero Street), Barangay Pleasant Hills, City of Mandaluyong.




