RESOLUTION NO. 3158, S-2022

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR BENJAMIN S. ABALOS SIGN AND ENTER INTO A SISTERHOOD AND TWINNING NEGOTIATION AND AGREEMENT BETWEEN THE MUNICIPALITY OF LUMBAN, LAGUNA AND THE CITY OF MANDALUYONG

WHEREAS, Lumban is a 3rd class municipality in the Province of Laguna, Philippines. According to the 2020 census, the Municipality holds a number of 16 Barangays with a population of 32,330 people. It has a total land area of 40.53 square kilometers or 15.65 square miles which constitutes 2.10% of the entire province area and considered as one of Laguna's oldest towns;

WHEREAS, the people of the Municipality of Lumban, Laguna represented by its Honorable Mayor Rolando G. Ubatay, through Lumban, Laguna Resolution No. 53, S-2022, expressed manifestation of the Municipality's strong desire to establish a sisterhood-community relation and town twinning agreement with the City of Mandaluyong, wherein the sisterhood relation may yield knowledge from each other's better practices with regard to local governance where the establishment of strategic business links will eventually lead to the promotion of general welfare;

WHEREAS, the Municipality of Lumban, Laguna firmly believes that forging ties with the City of Mandaluyong would pave way for the Municipality of Lumban for economic development, share/exchange knowledge in technology, tourism, culture and arts, planning and development, commerce, trade and industry, youth education and sports, environmental protection, public health and social services. With the City of Mandaluyong's success in commerce, industry, and civic programs and projects that are advantageous for the Municipality of Lumban, the sisterhood agreement will alleviate the living conditions of its constituents in terms of technical and financial assistance;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Lumban, Laguna to establish a sisterhood community-relations with the City of Mandaluyong.


