RESOLUTION NO. 3166, S-2022

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE COAST GUARD FOR THE USE OF THE LOT, SPACE AND ESTABLISHED BUILDING IN HULO FERRY STATION LOCATED AT CORONADO STREET IN BARANGAY HULO, MANDALUYONG CITY, FOR THE EXCLUSIVE USE BY THE MANDALUYONG COAST GUARD SUB-STATION PERSONNEL'S TEMPORARY BILLETING AND OFFICE SPACE

WHEREAS, as provided for in Section 2 of Republic Act No. 9993 or the Philippine Coast Guard Law of 2009, the Philippine Coast Guard (PCG) is established as an armed and uniformed service attached to the Department of Transportation and Communications (now Department of Transportation);

WHEREAS, the Philippine Coast Guard has an existing Coast Guard Sub-Station in the City of Mandaluyong tasked primarily to protect and safeguard the waters of Mandaluyong City, including its marine resources;

WHEREAS, the City Government of Mandaluyong has built and maintained a lot, space and the building established in Hulo Ferry Station located at Coronado Street, Barangay Hulo, Mandaluyong City;

WHEREAS, in the interest of public service, the City Government of Mandaluyong willingly allows the Philippine Coast Guard, Mandaluyong Coast Guard Sub-Station's personnel the exclusive and temporary use of the lot, space and building established in Hulo Ferry Station located at Coronado Street, Barangay Hulo, Mandaluyong City, as temporary billeting and office space;

WHEREAS, a Memorandum of Agreement has been drafted to cover this legal arrangement between the Philippine Coast Guard and the City Government of Mandaluyong;

WHEREAS, relative thereto, the City Legal Department reviewed the above-mentioned draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum of Agreement with the Philippine Coast Guard for the use of the lot, space and established building in Hulo Ferry Station located at Coronado street in Barangay Hulo, Mandaluyong City, for the exclusive use by the Mandaluyong Coast Guard sub-station personnel's temporary billeting and office space.




