WHEREAS, DR. CESAR J. TUTAAN's experiences include: Pediatric Resident in the Department of Pediatrics at The Medical City from 1993-1996; Pediatric Consultant at St. Therese Hospital from 1998-2004; Pediatric Consultant at St. Patrick Clinic from 2002-2004 and as Medical Officer V at the Mandaluyong City Health Department from 2004-2016 and at the Mandaluyong City Medical Center from 2016 until his appointment as Government Department Head II on September 1, 2022;

WHEREAS, his appointment as City Government Department Head II in the Mandaluyong City Medical Center is considered as a promotion premised on his qualifications, familiarity with the job, accomplishments in the past, trainings and work experience, known probity and competence that has gained the trust and respect of the appointing authority;

WHEREAS, the services of DR. CESAR J. 



ADOPTED on this 20<sup>th</sup> day of September 2022, in the City of Mandaluyong.




