WHEREAS, Republic Act No. 11037 or An Act Institutionalizing a National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition Among Filipino Children and Appropriating Funds Therefor, aims for the State to establish a comprehensive national feeding program to address undernutrition among Filipino children in particular;

WHEREAS, Section 4(a) of the aforementioned Republic Act states that the DSWD, in coordination with the local government units, shall implement this feeding program for undernourished children aged three to five years old, which shall include the provision of at least one (1) fortified meal for a period of not less than one hundred twenty (120) days in a year;

WHEREAS, the Supplemental Feeding Program, the provision of food in addition to the regular meals for children between 2 to 4 years old enrolled in Child Centers and Supervised Neighborhood, play as part of the Department of Social Welfare and Development's (DSWD) contribution to the early childhood care and development program of the government;

WHEREAS, the 12th Cycle of the Supplemental Feeding Program aims to target 6,300 day care children as its beneficiaries in order to make the City's nutrition program relevant and responsive to the needs of its constituents, especially the undernourished and malnourished children;
