RESOLUTION NO. 3169, S-2022

A RESOLUTION AMENDING RESOLUTION NO. 3150, S-2022 ENTITLED "RESOLUTION ALLOWING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS, IN BEHALF OF THE CITY OF MANDALUYONG, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH DR. VICTOR R. POTENCIANO MEDICAL CENTER, INC. (VRPMC) FOR THE USE OF THE CITY'S AIR SPACE IN SIERRA MADRE ST. TO CONNECT THE VRPMC MAIN BUILDING TO THEIR CAR PARK BUILDING"

WHEREAS, Resolution No. 3150, S-2022 entitled: "Resolution Allowing the Honorable City Mayor Benjamin S. Abalos, in Behalf of the City of Mandaluyong, to Enter into and Sign the Memorandum of Agreement with Dr. Victor R. Potenciano Medical Center, Inc. (VRPMC) for the Use of the City's Air Space in Sierra Madre St. to Connect the VRPMC Main Building to their Car Park Building" was approved last August 25, 2022;

WHEREAS, on September 6, 2022, Ms. Ma. Victoria P. Vergel De Dios, President of VRP Medical Center, wrote to the Sangguniang Panlungsod to request for the correction of the area indicated in the said Resolution;

WHEREAS, there is a need to amend some parts of the said Resolution to resolve the said discrepancy of the bridgeway area and help the said institution in their intention to comply with the requirements of the BFP Mandaluyong for emergency exit ramps.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to amend some parts of the Resolution to read as follow:

- WHEREAS, the said bridgeway consisting of sixty three square meters (63 sqm) will traverse the airspace of Sierra Madre Street, Brgy. Highway Hills, Mandaluyong City, thus, VRPMC will need to pay rent for the airspace that the bridgeway shall occupy;
- WHEREAS, as per the Office of the City Assessor, the annual rates imposed by the City for corridors or hallways traversing an airspace is twenty percent (20%) of Php 731.34/sqm multiplied by the total area of the said corridor or hallway;
- WHEREAS, considering the proposed bridgeway is sixty three square meters (63 sqm), an annual rental rate of Php 9,214.38 was suggested by the Office of the City Assessor, to which VRPMC has expressed its acquiescence thereto.




