**RESOLUTION NO. 3177, S-2022**



RESOLUTION RATIFYING, CONFIRMING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM AND APPROVING THE AIP OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2022 TO INCLUDE THE PROCUREMENT OF MODULAR TENTS FOR DISASTER AND EMERGENCIES FOR CALENDAR YEAR 2022

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the year 2022;

WHEREAS, due to the exigencies of public service, there are various programs, projects and activities (PPAs) that need to be adopted, funded and implemented by different offices of the City Government of Mandaluyong;

WHEREAS, the sources of funds for these various PPAs have been identified and will be appropriated through Trust Liability Fund for Calendar Year 2022;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include the procurement of the Modular Tents for Disaster and Emergencies.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to ratify, confirm the Supplemental Annual Investment Program and approve the AIP of the City Government of Mandaluyong for the year 2022 to include the procurement of Modular Tents for Disaster and Emergencies for Calendar Year 2022.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the City Mayor, City Planning and Development Department, City Disaster Risk Reduction Management Office, City Budget Department, City Accounting Department and City Treasurer's Department for their information, guidance and reference.
