RESOLUTION ADOPTING AND APPROVING

FOR THE PERIOD 2023-2025

WHEREAS, the City Government of Mandaluyong conducted training and workshop for the formulation of the Executive-Legislative Agenda-Capacity Development (ELA-CAPDEV) in collaboration with DILG and attended by all Department Heads, Sangguniang Panlungsod Members and no less than Honorable City Mayor Benjamin S. Abalos;

WHEREAS, the ELA-CAPDEV of the City Government of Mandaluyong are mutually developed and agreed upon by the executive and legislative branches of the City of Mandaluyong in consultation with the various concerned stakeholders towards a common vision for the locality;

WHEREAS, the formulated ELA-CAPDEV, in compliance with the existing laws, rules and regulations, shall be submitted to the Department of the Interior and Local Government (DILG) as required by the existing and current laws and issuances.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to adopt and approve the Executive Legislative Agenda – Capacity Development (ELA-CAPDEV) of the City Government of Mandaluyong for the period 2022-2025.




