RESOLUTION NO. 3183, S-2022

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN AND ISSUE A DEED OF ABSOLUTE CONVEYANCE TO ALL HOUSING PROJECT AWARDEES/BENEFICIARIES WHO HAVE COMPLETED THEIR AMORTIZATION WITH THE CITY GOVERNMENT

WHEREAS, on May 9, 2022, the Honorable City Mayor Benjamin S. Abalos was elected as the new City Mayor of the City of Mandaluyong, during following the National and Local Elections;

WHEREAS, the Honorable Benjamin S. Abalos has served the then Municipal Government of Mandaluyong as Mayor from 1988 to 1998 and during the early years of his incumbency as City Mayor, he led the officialdom of the City Government to adopt a project dubbed as Land for the Landless and Home for the Homeless program, which was envisioned to lift the poorest among the poor of our constituents from the bondage of squatting in public, as well as in some private lands in the City;

WHEREAS, the said project of the City Government is currently being managed by the Mandaluyong Housing Development Department, under the management of Atty. Sherwin S.J. Enriquez;

WHEREAS, since the conception of the project some thirty (30) years now, some of the beneficiaries have fully paid the monthly amortization over the lot or unit awarded to them;

WHEREAS, considering the above premise, it is but fair, just and equitable for the Sangguniang Panlungsod to authorize the Honorable City Mayor Benjamin S. Abalos to issue a Deed of Absolute Conveyance in favor of those who have totally paid their monthly amortization in the acquisition of the real property awarded to them as beneficiaries under the Land for the Landless and Home for the Homeless Program of the government;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES to authorize the Honorable City Mayor Benjamin S. Abalos to sign and issue a Deed of Absolute Conveyance to all project awardees/beneficiaries who have completed their amortization with the City Government.




