RESOLUTION NO. 3192, S-2022

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ACCEPT AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT, THE FORMAL ACCEPTANCE OF DONATION EXECUTED IN FAVOR OF THE NATIONAL GRID CORPORATION OF THE PHILIPPINES IN RELATION TO THE COVID-19 RESPONSE OF THE CITY

WHEREAS, on March 08, 2020, President Rodrigo Roa Duterte issued Presidential Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines due to the COVID-19 pandemic;

WHEREAS, by virtue of Ordinance No. 759, S-2020, the Sangguniang Panlungsod declared the City of Mandaluyong under the State of Calamity due to the spread of the COVID-19;

WHEREAS, in view of the existing public health emergency, there was a need of support to many Madaleños by the City Government especially in response to its COVID-19 testing efforts;

WHEREAS, the National Grid Corporation of the Philippines donated to the City Government of Mandaluyong medical services consisting of 50 units of Testing Booths, COVID-19 Total Antibody Testing Services for 1,984 patients, COVID-19 Antigen Rapid Diagnostic Testing Services for 2,712 patients, and COVID-19 RT-PCR Testing Services for 445 patients, in the total amount of P5,164,000.00 to help the City's effort against COVID-19;

WHEREAS, pursuant to Section 458 and Section 22 of the Local Government Code of 1991, the City Government of Mandaluyong has the power to grant and accept donations through the approved Resolution of the Sangguniang Panlungsod;

WHEREAS, the Department of the Interior and Local Government Memorandum Circular No. 2008-55 dated April 1, 2008 with the subject "Guidelines on the Acceptance and Processing of Foreign and Local Donations During Emergency and Disaster Situations" referred to Administrative Order No. 2007-0017 of the Department of Health provides that there shall be no donation for purposes of emergencies and disaster situations, whether from international or local source, unless a formal acceptance for the purpose has been issued;

WHEREAS, relative thereto, the City Legal Department reviewed the draft of Acceptance of Donation to be executed by the City Government of Mandaluyong, and the same has been found to be reasonably and properly crafted and in accordance with law;

WHEREAS, for that purpose, there is a need to pass a Resolution signifying the acceptance of the donation, and authorizing the Honorable City Mayor Benjamin S. Abalos to sign the Acceptance of Donation and subsequent related agreements or documents for and in behalf of the City Government.

RESOLVED, FURTHER, to make representation with the Donor to observe the guidelines set forth under DOH AO NO. 2007-0017 dated May 28, 2007.

RESOLVED, FURTHERMORE, for the City Government of Mandaluyong to comply with the undertakings in the Acceptance of Donation.

RESOLVED, FINALLY, that copy of this Resolution be furnished to the Office of the City Mayor, Office of the City Health Officer, and the City General Services Department for their information and appropriate action.




