**RESOLUTION NO. 3195, S-2022**

**A RESOLUTION ESTABLISHING THE PLEASANT HILLS LYING-IN CLINIC, MAUWAY LYING-IN CLINIC AND PEOPLE'S LYING-IN CLINIC AS BIRTHING FACILITIES, AS A REQUIREMENT TO SECURE A LICENSE TO OPERATE FROM THE DEPARTMENT OF HEALTH**

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides that "the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;"

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that "the State shall protect and promote the right to health of the people and instill health consciousness among them;"

WHEREAS, Section 17 of R.A. No. 7160, otherwise known as the Local Government Code of 1991, provides that "local government units shall endeavor to be self-reliant and shall continue exercising powers and discharging the duties and functions currently vested upon them and shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services enumerated herein. Subject to the provisions of Title Five, Book 1 of this Code, health services include hospitals and other tertiary health services";

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act, aims to progressively realize Universal Health Care through a systematic approach and clear delineation of roles of key agencies and stakeholders towards better performance in the health system, and to ensure that all Filipinos are guaranteed equitable access to quality and affordable healthcare goods and services;

WHEREAS, Section 27 (b) of the said Act states that the "Department of Health shall institute a licensing and regulatory system for stand-alone health facilities, including those providing ambulatory and primary care services, and other modes of health service provision";

WHEREAS, on September 30, 2020, the Department of Health issued Department Circular No. 2015-0392 and Administrative Order No. 2020-0047, setting the Rules and Regulations Governing the Licensure of Primary Care Facilities in the Philippines;

WHEREAS, the said Rules and Regulations set the guidelines and minimum standards and requirements for the licensing and accreditation of primary care facilities, as well as the licensing standards of ancillary services of primary care facilities in the country;
