**RESOLUTION NO. 3197, S-2022**

**RESOLUTION AMENDING RESOLUTION NO. 3119, S-2022 FIXING THE DAY, TIME AND PLACE OF THE REGULAR SESSIONS OF THE TWELFTH (12TH) SANGGUNIANG PANLUNGSOD OF MANDALUYONG**

BE IT ADOPTED by the Sangguniang Panlungsod of Mandaluyong, in session assembled:

WHEREAS, Section 52 (a), Chapter 3, Title Two, Book 1 of the Local Government Code of 1991, otherwise known as Republic Act 7160, provides that, "On the first day of the session immediately following the election of its members, the Sanggunian shall, by Resolution, fix the day, time and place of its regular sessions. The minimum number of regular sessions shall be once a week for the Sangguniang Panlalawigan, Sangguniang Panlungsod, and Sangguniang Bayan and twice a month for the Sangguniang Barangay";

WHEREAS, in accordance therewith, the regular session of the Sangguniang Panlungsod was scheduled on a Tuesday at 10:00AM every week. However, the Body finds it more practical to amend the day as follows:

DAY:	Monday
TIME:	10:00 AM
PLACE:	Sangguniang Panlungsod Session Hall or in any place as the Presiding Officer may designate

WHEREAS, special sessions may also be called when public interest so demands, as often as necessary and in the manner provided for and authorized by law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to amend the day, time and place of the regular sessions of the Twelfth (12th) Sangguniang Panlungsod of Mandaluyong.

ADOPTED on this 29<sup>th</sup> day of November 2022, in the City of Mandaluyong.
