RESOLUTION RECOGNIZING PINAGSAMANG LAKAS NG KABATAAN (PILAK) AND ALYANSA NG NAGKAKAISA AT AKTIBONG KABATAAN NG HULO (ANAK NG HULO) AS CIVIL SOCIETY ORGANIZATIONS IN THE CITY OF MANDALUYONG

WHEREAS, the PINAGSAMANG LAKAS NG KABATAAN (PILAK) and ALYANSA NG NAGKAKAISA AT AKTIBONG KABATAAN NG HULO (ANAK NG HULO) based in the City of Mandaluyong, have sought recognition before this Sanggunian pursuant to the provision of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" and its Implementing Rules and Regulations;

NOW, THEREFORE, and the above premises considered and upon motion duly seconded, the Sangguniang Panlungsod of the City of Mandaluyong, RESOLVED, as it hereby RESOLVES, to recognize PINAGSAMANG LAKAS NG KABATAAN (PILAK) and ALYANSA NG NAGKAKAISA AT AKTIBONG KABATAAN NG HULO (ANAK NG HULO).

RESOLVED, further, to direct, as the Sanggunian Secretary is hereby directed, to issue the corresponding Certificates of Recognition to the PINAGSAMANG LAKAS NG KABATAAN (PILAK) and ALYANSA NG NAGKAKAISA AT AKTIBONG KABATAAN NG HULO (ANAK NG HULO).
