RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT CONTRACT WITH 3FJ CONSTRUCTION FOR THE DRAINAGE IMPROVEMENT LOCATED AT NANIRAHAN STREET, BARANGAY MABINI J. RIZAL, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the drainage improvement located at Nanirahan Street, Barangay Mabini J. Rizal, City of Mandaluyong;

WHEREAS, on November 29, 2022 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the two (2) bidders that participated in the aforesaid public bidding, the firm doing business under the name of 3FJ Construction, with business address at #11 Margarita Compound, Atlas Road, San Bartolome, Novaliches, Quezon City has been established to have the Lowest Calculated Responsive Bid in the amount of FIVE MILLION TWENTY ONE THOUSAND SEVEN HUNDRED SIXTY SEVEN PESOS (₱5,021,767.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;



ABALOS, to sign the Project Contract with 3FJ Construction for the drainage improvement located at Nanirahan Street, Barangay Mabini J. Rizal, City of Mandaluyong.

ADOPTED on this 14th day of December 2022, in the City of Mandaluyong.


