**RESOLUTION AUTHORIZING THE HONORABLE
CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE
PROJECT CONTRACT WITH IPM CONSTRUCTION
AND DEVELOPMENT CORPORATION FOR THE
SANITATION SERVICES (GARBAGE COLLECTION)
FOR DISTRICTS I & II, CITY OF MANDALUYONG**

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the sanitation services (garbage collection) for Districts I & II, City of Mandaluyong;

WHEREAS, on November 29, 2022 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein one (1) bidder participated by submitting its abstract of the proposals to the Bids and Awards Committee;

WHEREAS, the lone bidder that participated in the aforesaid public bidding, the firm doing business under the name of IPM Construction and Development Corporation, with business address at Penthouse, The Taipan Place Don F. Ortigas Jr. Road, Ortigas Center, Pasig City has been found to have the Single Calculated and Responsive Bid in the amount of TWENTY EIGHT MILLION ONE HUNDRED SEVENTY SIX THOUSAND TWO HUNDRED FIFTY SEVEN PESOS AND FORTY CENTAVOS (₱28,176,257.40) PER MONTH OR THREE HUNDRED THIRTY EIGHT MILLION ONE HUNDRED FIFTEEN THOUSAND EIGHTY EIGHT PESOS AND EIGHTY CENTAVOS (₱338,115,088.80) for one year;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;


WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of IPM Construction and Development Corporation has the Single Calculated and Responsive Bid and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS, to sign the Project Contract with IPM Construction and Development Corporation for the sanitation services (garbage collection) for Districts I & II, City of Mandaluyong.

ADOPTED on this 14th day of December 2022, in the City of Mandaluyong.


