**RESOLUTION AUTHORIZING THE HONORABLE
CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE
PROJECT CONTRACT WITH GOLDEN Z-5
SECURITY AND INVESTIGATION AGENCY, INC.
FOR THE SECURITY SERVICES OF THE CITY
GOVERNMENT OF MANDALUYONG**

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the security services of the City Government of Mandaluyong;

WHEREAS, on November 29, 2022 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the two (2) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Golden Z-5 Security and Investigation Agency, Inc., with business address at 363 Dr. Jose Fernandez Street, Barangay Highway Hills, Mandaluyong City has been established to have the Lowest Calculated Responsive Bid in the amount of SIX MILLION FOUR HUNDRED FORTY FOUR THOUSAND FIVE HUNDRED THIRTY FOUR PESOS AND EIGHTEEN CENTAVOS (₱6,444,534.18) per month or SEVENTY SEVEN MILLION THREE HUNDRED THIRTY FOUR THOUSAND FOUR HUNDRED TEN PESOS AND SIXTEEN CENTAVOS (₱77,334,410.16) per year;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;


WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.




