**RESOLUTION AUTHORIZING CITY MAYOR
BENJAMIN S. ABALOS TO SIGN AND ENTER
INTO A MEMORANDUM OF AGREEMENT WITH
PROJECT INCLUSION NETWORK, INC. FOR THE
PROMOTION OF THE WELFARE OF PERSONS
WITH DISABILITIES**

WHEREAS, the local government of Mandaluyong, through the Persons with Disabilities Affairs Division, formulates and implements policies, plans and programs for the promotion of the welfare of Persons with Disabilities in coordination with concerned national and local government agencies;

WHEREAS, Project Inclusion Network, Inc. is a non-stock and non-profit organization duly organized and registered with the Securities and Exchange Commission that continually advocates for a nation where Persons with Disabilities are able to promote their fullest potentials to participate and contribute to society;

WHEREAS, Project Inclusion Network, Inc. has a program called SUCCEED or Scaling Up Capacities of Community Based Enterprises for the Economic Empowerment of Persons with Disability whose aim is to develop and improve the capabilities of Persons with Disability-led local enterprises and promote inclusive and sustainable business practices through organizational development, partnerships with local economy drivers, access to start-up capital and long term market support;

WHEREAS, the parties agreed to collaborate in piloting the SUCCEED PROGRAM which aim to realize the rights of Persons with Disability to a full and productive life through employment and entrepreneurship opportunities as enshrined in Republic Act No. 7277;

WHEREAS, the Agreement shall be in force for a period of one (1) year from approval of this Resolution and may be extended for such period as may be agreed upon, in writing, by the parties;


WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS, to sign and enter into a Memorandum of Agreement with Project Inclusion Network, Inc. for the promotion of the welfare of persons with disabilities.

ADOPTED on this 14th day of December 2022, in the City of Mandaluyong.


