RESOLUTION NO. 3228, S-2023

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT CONTRACT WITH ALEXA TRADING AND CONSTRUCTION FOR THE CONSTRUCTION OF A FIVE (5) STOREY EVACUATION CENTER AND MULTI-PURPOSE BUILDING LOCATED AT ACACIA LANE CORNER F. FABELLA STREET, BARANGAY ADDITION HILLS, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the construction of a five (5) storey Evacuation Center and Multi-purpose building located at Acacia Lane Corner F. Fabella Street, Barangay Addition Hills, City of Mandaluyong;

WHEREAS, on January 6, 2023, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the two (2) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Alexa Trading and Construction, with business address at #10 Delos Reyes Street, Project 8, Quezon City has been established to have the Lowest Calculated Responsive Bid in the amount of TWO HUNDRED TWENTY FOUR MILLION ONE HUNDRED FORTY FOUR THOUSAND THREE HUNDRED NINETY SEVEN PESOS AND FORTY CENTAVOS (P224,144,397.40) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Alexa Trading and Construction is the lowest and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS, to sign the Project Contract with Alexa Trading and Construction for the construction of a five (5) storey Evacuation Center and Multi-purpose building located at Acacia Lane Corner F. Fabella Street, Barangay Addition Hills, City of Mandaluyong.
