**RESOLUTION RECOGNIZING VARIOUS NON-

WHEREAS, the following Organizations based in the City of Mandaluyong, have sought recognition before this Sanggunian pursuant to the provision of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" and its Implementing Rules and Regulations:

NOW, THEREFORE, and the above premises considered and upon motion duly seconded, the Sangguniang Panlungsod of the City of Mandaluyong, RESOLVED, as it hereby RESOLVES, to recognize various Non-Governmental Organizations as Civil Society Organizations in the City of Mandaluyong.


RESOLVED, further, to direct, as the Sanggunian Secretary is hereby directed, to issue the corresponding Certificates of Recognition to the above-mentioned Non-Governmental Organizations.
