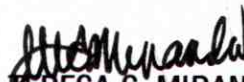

ADOPTED on this 13th day of February 2023, in the City of Mandaluyong.

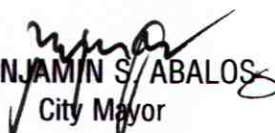

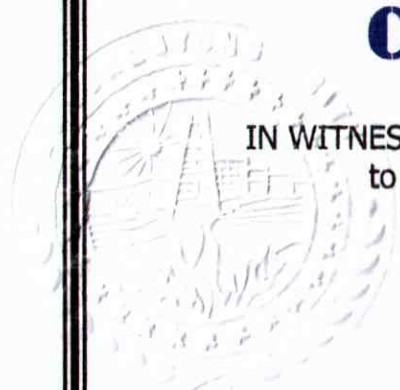
