RESOLUTION NO. 3341, S-2023



A RESOLUTION AUTHORIZING DR. CESAR TUTAAN, MEDICAL DIRECTOR OF THE MANDALUYONG CITY MEDICAL CENTER (MCMC), REPRESENTING THE CITY OF MANDALUYONG, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH DR. BRIAN CHRISTOPHER ANG, REPRESENTING PRIME HEALTH IMAGING CORPORATION, FOR THE RENDERING OF POSITRON EMISSION TOMOGRAPHY – COMPUTED TOMOGRAPHY (PET-CT) SERVICES

WHEREAS, Prime Health Imaging Corporation (Prime) is a corporation duly established and existing in accordance with the laws of the Republic of the Philippines, duly represented by Dr. Brian Christopher Ang, its Medical Director;

WHEREAS, the Mandaluyong City Medical Center (MCMC) is a government hospital duly organized and existing in accordance with the laws of the Republic of the Philippines, duly represented by Dr. Cesar Tutaan, its Medical Director;

WHEREAS, MCMC is a PhilHealth-accredited/DOH-licensed Secondary Level Government Health Facility which has the services, medical doctors, and personnel capable to provide medical and hospitalization to its patients;

WHEREAS, Prime is offering its services to the constituents of the City of Mandaluyong through MCMC at a special rate;

WHEREAS, a Memorandum of Agreement has been drafted to cover this partnership between the City of Mandaluyong and Prime Health Imaging Corporation;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with the law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Dr. Cesar Tutaan, Medical Director of MCMC, representing the City of Mandaluyong, to enter into and sign the Memorandum of Agreement with Dr. Brian Christopher Ang, representing Prime Health Imaging Corporation, for the rendering of PET-CT services.

This Resolution shall take effect immediately upon its approval.
