RESOLUTION NO. 3243, S-2023

RESOLUTION RATIFYING, CONFIRMING, AND APPROVING SUPPLEMENTAL THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR CALENDAR YEAR 2023 TO INCLUDE THE VARIOUS PROGRAMS. PROJECTS AND ACTIVITIES (PPAs) UNDER THE SPECIAL TRUST FUND (TRUST LIABILITY-DRRM) OF THE MANDALUYONG CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (CDRRMO)

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Year 2023;

WHEREAS, on February 12, 2023, a fire incident happened at Block 32 Extension in Barangay Addition Hills where 199 families were displaced and in dire need of assistance;

WHEREAS, the funds intended for DRRM PPAs relative to assistance and support to disaster victims and response teams cannot be taken from the Quick Response Fund (QRF) of the LDRRMF as there was no declaration of a state of calamity. In such cases, the Special Trust Fund (Trust Liability-DRRM) can be used for the purpose;

WHEREAS, however, the Mandaluyong CDRRMO already submitted its AIP for CY 2023, and there was no DRRM PPAs specified in the 2023 AIP that will require the use of the Special Trust Fund;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include those PPAs covered by the Special Trust Fund (Trust Liability-DRRM).

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to ratify, confirm and approve the Supplemental Annual Investment Program (AIP) for Calendar Year 2023 of the City Government of Mandaluyong to include the various programs, projects and activities (PPAs) under the Special Trust Fund (Trust Liability-DRRM) of the Mandaluyong City Disaster Risk Reduction and Management Office (CDRRMO).

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the City Mayor, City Budget Department, City Accounting Department and City Treasurer's Department for their information, guidance and reference.

ADOPTED on this 27th day of February 2023, in the City of Mandaluyong.
