RESOLUTION NO. 3249, S-2023

**A RESOLUTION RECOMMENDING THAT THE
HONORABLE CITY MAYOR SIGN AND ENTER INTO A
SISTERHOOD AND TWINNING NEGOTIATION AND
AGREEMENT BETWEEN THE MUNICIPALITY OF
CANDIJAY, BOHOL AND THE CITY OF MANDALUYONG**

WHEREAS, Candijay is a 4th class municipality in the Province of Bohol, Philippines. According to the 2020 census, the Municipality holds a number of 21 Barangays with a population of 30,119 people. It has a total land area of 103.26 square kilometers or 39.87 square miles which constitutes 2.16% of Bohol's total area;

WHEREAS, the people of the Municipality of Candijay, Bohol represented by its Honorable Mayor Thamar C. Olaivar, through Candijay, Bohol Resolution No. 2023-02-113, expressed manifestation of the Municipality's strong desire to establish a sisterhood-community relation and town twinning agreement with the City of Mandaluyong, wherein the sisterhood relation offers beneficial opportunities for both parties not only for strengthening the political will of the Local Officials in performing its duties and functions to deliver the basic services to their respective constituents, it will also enhance in achieving the socio-economic development program undertaken by LGU-Candijay and the City of Mandaluyong;

WHEREAS, the Municipality of Candijay, Bohol firmly believes that forging ties with the City of Mandaluyong would pave way "to avail whatever good and services that can be shared and replicated in achieving the vision of making the Municipality of Candijay a flourishing tourist destination in the southern part of Bohol anchored on agri-based development and as an eco-culturally diverse community";

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor to accept the intention of the Municipality of Candijay, Bohol, to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor to sign and enter into a Sisterhood Agreement between the Municipality of Candijay, Bohol and the City of Mandaluyong;

Let copy of this Resolution be furnished the Office of the Municipal Mayor, Vice Mayor and Council Members of Candijay, Bohol for their information and guidance.
