## **RESOLUTION NO. 3252, S-2023**

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR BENJAMIN S. ABALOS SIGN AND ENTER INTO A SISTERHOOD AND TWINNING NEGOTIATION AND AGREEMENT BETWEEN THE MUNICIPALITY OF PANGANIBAN, CATANDUANES AND THE CITY OF MANDALUYONG

WHEREAS, Panganiban is a 5th class municipality in the Province of Catanduanes. According to the 2020 census, it has a population of 9,713 people. It has a total land area of 79.96 square kilometers or 30.87 square miles, which constitutes 5.36% of Catanduanes's total area:

WHEREAS, the people of the Municipality of Panganiban, Catanduanes, represented by its Honorable Mayor Cesar J. Robles, through Panganiban, Catanduanes Resolution No. 05-23, expressed manifestation of the Municipality's strong desire to establish a sisterhood-community relation and town twinning agreement with the City of Mandaluyong, wherein the sisterhood relation is the most prestigious type of inter-LGU cooperation, both domestically and internationally, allowing partner communities or local governments to carry out beneficial joint projects;

WHEREAS, the Municipality of Panganiban, Catanduanes firmly believes that forging ties with the City of Mandaluyong would pave the way for an increase in trade, business and tourists for both parties while also fostering goodwill and greater understanding through direct interactions between the local government and communities involved;

WHEREAS, the Municipality of Panganiban, Catanduanes firmly believes that they can benchmark and/or improve existing policies with careful consideration to the promulgated legislation, executive orders, technologies and best practices duly implemented by the City of Mandaluyong;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Panganiban, Catanduanes, to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood Agreement between the Municipality of Panganiban, Catanduanes and the City of Mandaluyong;

CESAR J. ROBLES TO SIGN THE DOCUMENTS THAT MAY BE ENTERED INTO, FOR AND ON BEHALF OF THE MUNICIPALITY.

WHEREAS, Local Government Unit (LGU's) nationwide are encouraged to explore more opportunities for twinning relationships with their LGU counterparts as means to foster goodwill and understanding, as well as other socio-cultural-economic aspect of development;

WHEREAS, the twinning relationship of LGU will pave the way for an increase in trade. business and tourists for both parties while also fostering goodwill and greater understanding through direct interactions between the local government and communities involved;

WHERAS, sisterhood and twinning help LGU promote mutual understanding and goodwill at the many levels of local government administrator, promising its resident's peace, stability, and prosperity today in the future.

WHEREAS, the Municipality of Panganiban as a 5th -class municipality can benchmark and/or improve existing policies with careful consideration to the promulgated legislation. executive orders, technologies, and best practices duly implemented by the City of Mandaluyong;

NOW, THEREFORE, on motion of Hon. Melchor J. Velasco, duly seconded by all members present, be it;

RESOLVED, as it is hereby resolved, to forge a Sister-City relationship and Town Twinning agreement with the City of Mandaluyong to foster and promote exchanges in various fields of endeavors as may be agreed upon likewise granting authority to the Municipal Mayor, Hon. Cesar J. Robles to sign the documents that may be entered into, for and on behalf of the Municipality.
