WHEREAS, the DAVAO-BICOL-ILONGO-SAMAR-LEYTE-TAGALOG ASSOCIATION INC. has partially complied with the requirements prescribed under the Department of the Interior and Local Government Memorandum Circular No. 2022-083 issued on June 15, 2022, hence, the Committee recommends recognizing the association as Civil Society Organization (CSO) in the City of Mandaluyong;
