RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO SIGN THE PROJECT CONTRACT WITH 121 CONSTRUCTION CORPORATION FOR THE STREET IMPROVEMENT (ASPHALT OVERLAY) LOCATED AT MADISON STREET (FROM EDSA TO PIONEER STREET), BARANGAY BARANGKA ILAYA, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the street improvement (asphalt overlay) located at Madison Street (from EDSA to Pioneer Street), Barangay Barangka Ilaya, City of Mandaluyong;

WHEREAS, on December 6, 2023 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting its abstract of the proposals to the Bids and Awards Committee;

WHEREAS, in the aforesaid public bidding, the firm doing business under the name of 121 Construction Corporation, with business address at #418 Tumana, Sta. Maria, Bulacan has been established to have the Lowest Calculated Responsive Bid in the amount of SIX MILLION FOUR HUNDRED FORTY THOUSAND FIVE HUNDRED FORTY FOUR PESOS (₱6,440,544.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules:

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of 121 Construction Corporation is the lowest and most advantageous bid to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Local Chief Executive to sign the Project Contract with 121 Construction Corporation for the street improvement (asphalt overlay) located at Madison Street (from EDSA to Pioneer Street), Barangay Barangka Ilaya, City of Mandaluyong.
