**RESOLUTION NO. 3276, S-2023**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR THE WORK IMMERSION PARTNERSHIP WITH THE DEPARTMENT OF EDUCATION (DEPED) – MANDALUYONG**

WHEREAS, the City Government of Mandaluyong, through the Sangguniang Panlungsod, has been supporting the youth by providing quality education and training;

WHEREAS, the Department of Education (DepEd) introduced the K to 12 basic education reform program that includes Senior High School (SHS) with the major objective of ensuring the graduates of basic education are ready for employment, entrepreneurship and higher learning;

WHEREAS, the DepEd believes that for the delivery of SHS instruction, there is a need for school-industry partnership that will provide the school the necessary expertise and venue for practical, on-the-job, enterprise-based training for SHS learners;

WHEREAS, the DepEd-Mandaluyong schools are among those that will offer SHS school program to students in the community to carry out DepEd's objectives for SHS learners;

WHEREAS, the City Government of Mandaluyong, a staunch advocate for quality education is willing to cooperate and support the DepEd-Mandaluyong to carry out their goals in the Work Immersion Program for SHS learners;

WHEREAS, relative thereto, the City Legal Department reviewed the Draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonable and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor Benjamin S. Abalos to enter into and sign the Memorandum of Agreement with the DepEd-Mandaluyong in connection with Work Immersion Program for the SHS learners of the City of Mandaluyong.

RESOLVED, that copy of this Resolution be furnished to the Office of the City Mayor, City Administrator, Local School Board, Department of Education (DepEd) – Mandaluyong and City Accounting Department for their information and guidance.

This Resolution shall take effect immediately upon its approval.
