RESOLUTION NO. 3293, S-2023

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR BENJAMIN S. ABALOS SIGN AND ENTER INTO A SISTERHOOD AND TWINNING NEGOTIATION AND AGREEMENT BETWEEN THE MUNICIPALITY OF QUEZON, PROVINCE OF QUEZON AND THE CITY OF MANDALUYONG

WHEREAS, Quezon is a 5th class municipality in the Province of Quezon, Philippines. According to the 2020 census, the Municipality holds a number of 24 Barangays with a population of 15,886 people;

WHEREAS, the people of the Municipality of Quezon, Province of Quezon represented by Honorable Mayor Juan F. Escolano, through Municipality of Quezon, Province of Quezon Resolution No. 2023-14, expressed manifestation of the Municipality's strong desire to establish good relations and solidarity with the City of Mandaluyong, wherein the sisterhood relation may yield knowledge from the City's best practices with regard to local governance and the establishment of strategic business links may eventually lead to the promotion of general welfare;

WHEREAS, the Municipality of Quezon, Province of Quezon recognize the importance of the principle of equality and cooperation, and wish for its success to achieve the aspirations of the people;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;


WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Quezon, Province of Quezon, to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood and twinning negotiation and Agreement between the Municipality of Quezon, Province of Quezon and the City of Mandaluyong;

Let copy of this Resolution be furnished the Office of the Municipal Mayor, Vice Mayor and Council Members of Quezon, Province of Quezon for their information and guidance.
