RESOLUTION RATIFYING. CONFIRMING AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2023 TO INCLUDE THE OTHER PRIORITY PROJECTS UNDER CAPITAL OUTLAY (CO) OF THE CITY ENGINEERING AND BUILDING OFFICIALS DEPARTMENT FOR CY 2023

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of the City of Mandaluyong has prepared an Annual Investment Program (AIP) for the Calendar Year 2023;

WHEREAS, the AIP has always been focused on the City Government's Practical Visions and Strategic Directions, and Specific Objectives and Policy Decisions;

WHEREAS, due to the exigencies of public service, there are still other various programs, projects and activities (PPAs) that need to be adopted, funded and implemented by different offices of the City Government of Mandaluyong, such as the City Engineering and Building Officials Department;

WHEREAS, due to the discontinuance of the project in Hulo Bliss and construction of Block 34 covered court, the fund allocated therefor can be maximized and utilized for other priority projects such as asphalt overlay of dilapidated roads, site development of fire affected areas in Block 34, construction and improvement of Justice Hall building and memorial chapels at Garden of Life Cemetery, and installation of street lights;

WHEREAS, there is, therefore, a need to amend or submit a supplemental AIP to include the other priority projects of the City Engineering and Building Officials Department under its 2023 Capital Outlay.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod of the City of Mandaluyong, RESOLVED, as it hereby RESOLVES, to ratify, confirm and approve the Supplemental Annual Investment Program (AIP) of the City Government of Mandaluyong to include the Other Priority Projects under Capital Outlay (CO) of the City Engineering and Building Officials Department for CY 2023.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the City Mayor, City Engineering and Building Officials Department, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasurer's Department for their information, guidance and reference.
