RESOLUTION RATIFYING, CONFIRMING AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2023 TO INCLUDE THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES TO BE COVERED BY SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2023

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Calendar Year 2023;

WHEREAS, due to the exigencies of public service, there are various programs, projects and activities (PPAs) that need to be adopted, funded and implemented by different offices of the City Government of Mandaluyong.

WHEREAS, the sources of funds for these various PPAs have been identified and will be appropriated through Supplemental Budget No. 1 for CY 2023;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include those PPAs covered by the Supplemental Budget No. 1 for CY 2023.

NOW, THEREFORE, and upon motion duly seconded, the Sanggunian RESOLVED, as it hereby RESOLVES, to approve, ratify and confirm as the Supplemental Annual Investment Program (AIP) for Calendar Year 2023 of the City Government of Mandaluyong to include those PPAs covered by the Supplemental Budget No. 1 for CY 2023.
