## RESOLUTION NO. 3302, S-2023

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL DONG HWA UNIVERSITY AND THE CITY GOVERNMENT OF MANDALUYONG FOR THE GRANTING OF SCHOLARSHIP TO THE QUALIFIED HIGH SCHOOL GRADUATES OF MANDALUYONG CITY

WHEREAS, the City Government of Mandaluyong, through Sangguniang Panlungsod, has been supporting the youth by providing quality education and training;

WHEREAS, the City Government of Mandaluyong has been in partnership with different educational institutions in the delivery of quality education for its constituents;

WHEREAS, the National Dong Hwa University is a national research university located in Hualien, Taiwan which recognizes the importance of academic exchange and collaboration;

WHEREAS, the National Dong Hwa University offered to extend its support to the students of the City of Mandaluyong by providing scholarship grants for qualified high school graduates;

WHEREAS, the City of Government of Mandaluyong, a staunch advocate for quality education, is willing to assist and cooperate with the National Dong Hwa University to extend these scholarship grants with the qualified high school graduates in the City;

WHEREAS, a Memorandum of Understanding has been drafted to cover the collaboration of the National Dong Hwa University and the City Government of Mandaluyong to implement the scholarship grants;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Understanding that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum of Understanding with the National Dong Hwa University in connection with its scholarship grants for the qualified high school graduates of the City of Mandaluyong.

RESOLVED, FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, City Administrator, Local School Board, City Accounting Department and the National Dong Hwa University for their information and guidance.

This Resolution shall take effect immediately upon its approval.
