**A RESOLUTION RECOMMENDING THAT
HONORABLE CITY MAYOR BENJAMIN S. ABALOS
SIGN AND ENTER INTO A SISTERHOOD AND
TWINNING NEGOTIATION AND AGREEMENT
BETWEEN THE MUNICIPALITY OF ATOK, BENGUET
AND THE CITY OF MANDALUYONG**

WHEREAS, Municipality of Atok is a 4th class municipality in the Province of Benguet. According to the 2020 census, it has a population of 19,218 people.

WHEREAS, the people of the Municipality of Atok, Benguet represented by its Municipal Mayor, Honorable Franklin L. Smith, through Atok, Benguet Resolution No. 90-2023 expressed manifestation of the Municipality's strong desire to establish a sisterhood-community relation and town twinning agreement with the City of Mandaluyong, wherein the sisterhood relation will foster, promote, enhance and formalize a close relationship between the City of Mandaluyong and Atok, Benguet and also among their constituents;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Atok, Benguet to establish a sisterhood community-relations with the City of Mandaluyong.


NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood and Twinning Negotiation Agreement between the Municipality of Atok, Benguet and the City of Mandaluyong.


