RESOLUTION NO. 3317, S-2023

RESOLUTION EARNESTLY REQUESTING 4Ps PARTY LIST, THRU HONORABLE REPRESENTATIVE JONATHAN CLEMENT M. ABALOS II, TO PROVIDE MEDICAL AND DENTAL EQUIPMENT, WHEELCHAIRS, AND PATIENT TRANSPORT SERVICE VEHICLES (AMBULANCES) INTENDED FOR THE CITY OF MANDALUYONG TO ENSURE AVAILABILITY OF TRANSPORTATION DURING EMERGENCIES AND OTHER MEDICAL SERVICES

WHEREAS, the City of Mandaluyong has an estimated daytime population of one million five hundred thousand;

WHEREAS, presently, the Mandaluyong City Medical Center (MCMC) has a total of four (4) existing ambulances, two (2) of which experience mechanical problems and are undergoing repairs and to this day, there are only two (2) serviceable ambulance units operating for years within the area catering to sick people of 27 barangays;

WHEREAS, one of the basic and most important services that the government extends to its people is health services;

WHEREAS, two of the pressing problems of the MCMC is the lack of functional ambulance vehicle that can be used in transporting patients to nearest hospitals and lack of medical equipment needed;

WHEREAS, the request for medical and dental equipment, wheelchairs and patient transport service vehicles (ambulances) can be of great help in the promotion of basic health services and general welfare to our people especially to the indigent constituents who cannot afford to hire private vehicle in transporting patients to the nearest hospital and other medical services;

WHEREAS, towards this end, it is but proper and fitting to look for any agency or individual who can extend help and assistance in providing the said needs of the Local Government Unit of Mandaluyong.

NOW THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to earnestly request the 4Ps Party list, thru Honorable Representative Jonathan Clement M. Abalos II, to provide medical and dental equipment, wheelchairs, and patient transport service vehicles (ambulances) intended for the City of Mandaluyong to ensure availability of transportation during emergencies and other medical services;


RESOLVED, that copy of this resolution be furnished and delivered to the Office of Congressman JC Abalos, Honorable City Mayor Benjamin S. Abalos, City Mayor of Mandaluyong, and other offices concerned.
