**RESOLUTION NO. 3318, S-2023**



**A RESOLUTION RATIFYING THE PERTINENT  
ISSUANCES OF THE SANGGUNIANG BARANGAY OF  
BARANGAY ADDITIONS HILLS RELATING TO THE  
INSTALLATION OF A CELL SITE TOWER AND  
SIGNAL BOOSTER ON THE ROOFTOP OF ITS  
BARANGAY HALL BUILDING**

WHEREAS, Republic Act No. 7160 or the Local Government Code mandates that every local government unit shall ensure and support the development of appropriate and self-reliant economic and technological capabilities, and preserve the comfort and convenience of the inhabitants;

WHEREAS, under the same Code, the law treats barangay as the primary planning and implementing unit of government's policies, plans, programs, and activities in the community, and as a forum wherein the collective views of the people may express, crystallized and considered, and where disputes may be amicably settled;

WHEREAS, as a statutory power of the Sangguniang Barangay, the legislative body of the Barangay, it is within its power to regulate the use of multi-purpose halls, multi-purpose hall pavements, grain copra dryers, patios and other post-harvest facilities, Barangay waterworks, Barangay market, parking areas or other similar facilities constructed with government fund within the jurisdiction of the Barangay and charge reasonable fees for the use thereof;

WHEREAS, as regards the derivation of income of local government units, as provided by Section 18 of the Code, they shall have the power and authority to, among others, lease real properties held by it in its proprietary capacity and to apply its resources and assets for productive, development, or welfare purposes:

WHEREAS, it is, likewise, within the power of Sangguniang Barangay to enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and to promote the general welfare of their inhabitants, and authorize the Punong Barangay to enter into contracts in behalf of the Barangay in order for it to provide delivery of basic services to its constituents;

WHEREAS, Barangay Addition Hills, being one of the most populous and dense areas in the City, has, from time immemorial, faced issues relating to the fluctuating and deficient telecommunications signal from Globe Telecom, Inc. ("Globe");

WHEREAS, the prevalent concerns relating to the signal of Globe within the locality of Additions Hills have led to countless concerns affecting the delivery of basic services, the Sangguniang Panlungsod performance of disaster and emergency response measure, and unjustified hardship of residents of all ages and stature, as they scramble networks connection during the emergence of a global pandemic where all transactions and activities are done online;


RESOLVED FINALLY, that the Sangguniang Barangay of Barangay Addition Hills furnish the Sangguniang Panlungsod copies of Contract of Lease deemed executed for the afore-mentioned purposes.

ADOPTED on this 14<sup>th</sup> day of August 2023, in the City of Mandaluyong.


