RESOLUTION RATIFYING. CONFIRMING, SUPPLEMENTAL ANNUAL APPROVING THE (AIP) OF THE CITY INVESTMENT PROGRAM GOVERNMENT OF MANDALUYONG FOR CALENDAR YEAR 2023 TO INCLUDE THE LITIGATION/ACQUIRED ASSETS EXPENSES OF THE MANDALUYONG HOUSING AND DEVELOPMENT DEPARTMENT FOR THE PITONG GATANG PROPERTY AND CAVO SANCHEZ PROPERTY

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Year 2023;

WHEREAS, due to the exigencies of public service and to maximize the utilization of funds before the year ends, there are various programs, projects and activities (PPAs) that need to be adopted, funded, and implemented by different offices of the City Government of Mandaluyong, including the Mandaluyong Housing and Development Department;

WHEREAS, the City of Mandaluyong will acquire a parcel of land located at Aglipay Street, Barangay Old Zaniga consisting of Three Thousand Seven Hundred Fifty Eight (3,758) Square Meters, otherwise known as the "Pitong Gatang property". It will also transfer to its name the land title of three (3) parcels of land with an aggregate area of Three Thousand Two Hundred Eighty Seven (3,287) Square Meters located at Cavo Sanchez Street, Barangay Hagdan Bato Itaas, otherwise known as the "Cavo Sanchez property";

WHEREAS, the sources of funds to defray the cost of acquisition, transfer and other related expenses of these properties have been identified, and will be appropriated through Supplemental Budget No. 2 for CY 2023;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes in the original AIP.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm the Supplemental Annual Investment Program (AIP) for Calendar Year 2023 of the City Government of Mandaluyong to include the litigation/acquired assets expenses of the Mandaluyong Housing and Development Department for the Pitong Gatang property and Cavo Sanchez property.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the Mayor, Mandaluyong Housing and Development Department, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.
