**A RESOLUTION RECOMMENDING THAT HONORABLE
CITY MAYOR BENJAMIN S. ABALOS SIGN AND
ENTER INTO A SISTERHOOD AND TWINNING
NEGOTIATION AND AGREEMENT BETWEEN THE
MUNICIPALITY OF CALBIGA, PROVINCE OF SAMAR
AND THE CITY OF MANDALUYONG**

WHEREAS, the Municipality of Calbiga is a coastal municipality in the Province of Samar consisting of forty one (41) barangays with a total population of 23,310 more or less;

WHEREAS, Calbiga is known for its encompassing and immense Langun-Gobingob Caves, more popularly known as Langun-Calbiga Cave System. The cave system is the largest in the Philippines and is the second largest in Asia. Calbiga is a growing agricultural and educational municipality;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, the Municipality of Calbiga intends to undertake mutually beneficial partnership with the City of Mandaluyong thru its Mayor, Honorable Red L. Nacario, who manifested intention of city-town twinning arrangement becoming a sister municipality of Mandaluyong City to strengthen mutual understanding as well as generate meaningful exchange and collaboration for sustainable development, trade and investment, tourism, information technology, human development, culture and the arts, among other things;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Calbiga, Province of Samar, to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood and Twinning Negotiation Agreement between the Municipality of Calbiga, Province of Samar and the City of Mandaluyong.

Let copy of this Resolution be furnished the Office of the Mayor of Municipality of Calbiga, Province of Samar, Vice Mayor and its Council Members for their information and guidance.
