RESOLUTION NO. 3340, S-2023

**A RESOLUTION RECOMMENDING THAT
HONORABLE CITY MAYOR BENJAMIN S.
ABALOS SIGN AND ENTER INTO A SISTERHOOD
AND TWINNING NEGOTIATION AND AGREEMENT
BETWEEN THE MUNICIPALITY OF ALAMINOS,
LAGUNA AND THE CITY OF MANDALUYONG**

WHEREAS, the Municipality of Alaminos is a 3rd class municipality in the Province of Laguna, Philippines. According to the 2020 census, it has a population of 51,619 people. The Municipality of Alaminos is an agro-industrial town that lies within the third congressional district of the Province of Laguna and is a part of the Calabarzon region;

WHEREAS, the people of the Municipality of Alaminos, Laguna, represented by its Honorable Mayor Glenn P. Flores, through Alaminos, Laguna Resolution No. 112-2023, expressed manifestation of the Municipality's strong desire to establish a sisterhood-community relation and town twinning agreement with the City of Mandaluyong, wherein the sisterhood relation may yield knowledge from each other's better practices about local governance where the establishment of strategic business links will eventually lead to the promotion of general welfare;

WHEREAS, the Municipality of Alaminos, Laguna firmly believes that forging ties with the City of Mandaluyong would pave way to the best practices and experiences in the field of Public Service, Tourism and Culture, Urban Planning and Development, Commerce, Trade and Industry, Agriculture, Education and Health, Sports Development and Social Services, Science and Technology, among others;

WHEREAS, the Department of the Interior and Local Government (DILG) supports the sisterhood or town-twinning programs as expressed in the DILG Memorandum Circular No. 97306;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor BENJAMIN S. ABALOS to accept the intention of the Municipality of Alaminos, Laguna, to establish a sisterhood community-relations with the City of Mandaluyong.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor BENJAMIN S. ABALOS to sign and enter into a Sisterhood and Twinning Negotiation and Agreement between the Municipality of Alaminos, Laguna and the City of Mandaluyong;

Let copy of this Resolution be furnished the Office of the Municipal Mayor, Vice Mayor and Council Members of Alaminos, Laguna for their information and guidance.
